

City of Luxembourg's Recycling Centre - Internal rules and regulations

The operating procedures of the Recycling Centre are based on the City's Regulation on waste management (Règlement concernant la gestion des déchets) and its technical specifications, as well as Chapter F-4: Déchets of the City's tax regulations (Règlement-taxe).

Article 1: General

Access to the Recycling Centre and the use of the facilities are limited to residents of Luxembourg City and the municipality of Strassen, as well as all authorised persons.

Users are allowed to bring the materials on foot or by means of a vehicle.

As parking is limited, the transportation of waste materials by trailer, van, lorry, tow truck or any similar vehicle is only authorised if parking spaces are available. If there are no free parking spaces, access may be denied.

The City of Luxembourg reserves the right to verify the user's place of residence and refuse access to non-authorised persons.

It also reserves the right to refuse entry to users who refuse to comply with checks conducted prior to accessing the site.

By entering the Recycling Centre, on foot or by means of a vehicle, users accept these internal rules and regulations as legally binding.

After being disposed of in the appropriate containers, the City of Luxembourg becomes the owner of the materials.

Article 2: Opening hours

The Recycling Centre is open as follows:

Monday to Friday from 7:00 to 19:30 (last entrance at 19:20) and

Saturday from 8:30 to 18:00 (last entrance at 17:50).

The Recycling Centre is closed on Sundays and public holidays.

Article 3: Code of conduct for the site of the Recycling Centre

Users must follow the instructions given by Recycling Centre staff as well as those indicated on signs.

Users must not engage in any behaviour that could endanger themselves, others or the environment, or disrupt the smooth running of the site.

For security reasons, the speed limit is 10 km/h on the entire site.

While on site, users must take all measures to prevent accidents.

In the "monocharge" area, materials are unloaded directly from the vehicle into the container. In the "caddy" area, vehicles must be parked in a marked space and the materials brought on caddies to the corresponding containers.

Hazardous or toxic waste must be left (if possible, in the original packaging) at the SuperDrecksKëscht counter.

Users must clean up any mess made while unloading materials; cleaning equipment is provided by the City of Luxembourg.

Users are only allowed to remain on the site during the time needed to unload their materials. Once finished, they must leave the site immediately.

Accessing the interior of containers or taking materials out of them is strictly prohibited.

Smoking is not permitted anywhere on the site.

People under the influence of alcohol or drugs will be refused access.

Article 4: Reception of recyclable materials

The Recycling Centre accepts recyclable materials and hazardous waste under the conditions and within the limits stipulated by the City's Regulation on waste management and its technical specifications, provided that said waste was generated in Luxembourg City or the municipality of Strassen.

Recyclable materials must be clean since soiled materials cannot be recycled.

Materials must be separated before being brought to the Recycling Centre, and then placed in the appropriate containers marked by signs. Users can ask a staff member if they have any questions. Any cases of incorrectly sorted materials must be reported immediately to a Recycling Centre staff member.

Materials are accepted in quantities typical for a household. The daily limit is 1 m³ per household.

Larger quantities can be taken to the Recycling Centre after being authorised by the City of Luxembourg's Service Hygiène (Sanitation Department) and within the limits of the Recycling Centre's capacity.

Materials from a major repair/renovation or demolition/clearing works exceed the quantities typical for a household. In this case, please call 4796-3640 for information on the correct procedure.

The City of Luxembourg reserves the right to refuse materials that cannot be recycled due to their composition or condition.

The origin and condition of materials are verified by Recycling Centre staff.

Article 5: Liability

Entering the site of the Recycling Centre on foot or by the means of a vehicle is at the user's own risk.

Users are liable for any damage they cause while on the site.

Article 6: Penalties

Failure to comply with the City's Regulation on waste management and its technical specifications, as well as these internal rules and regulations, may result in the site manager asking the user to leave.

The college of aldermen of the City of Luxembourg also has the right to issue a temporary or, if necessary, permanent ban on accessing the site of the Recycling Centre.

Article 7: Entry into force

These internal rules and regulations shall enter into force on 14 February 2014.
